6. Climate Action Plan Kick-Off – Presentation by DNV GL

Betty Seto, DNV GL, presented information on the Climate Action Plan process and explained that the CAP will need to show the Town is mitigating Greenhouse Gas effects. DNV GL will be helping to facilitate the process and support Staff work on the process. Their work is funded by C/CAG.

Nathan Kinsey, DNV GL, presented a PowerPoint and explained how levels are determined and state law that applies to the project. Mr. Kinsey answered questions about the data and explained changes from 2005 (the baseline year) and 2010.

The Committee reviewed the potential measures for the Climate Action Plan and came up with a draft list. This list will be discussed at the next meeting and staff will provide information on Green Building and LEED certification. The next steps include finalization of measures (June) and then Staff will work on the Climate Action Plan.
